

B2 - Business e-Visa (VOA)

A person who is a national of visa on arrival country/special entity who will visit Indonesia for business-related purposes



Stay

With this visa you can

- Carry out activities related to business, meetings, or purchase of goods including but not limited to checking goods at the office, factory, or production site of goods.
- Discuss, negotiate, and/or sign business contracts.
- Conducting activities related to tourism, and visiting friends or family.

You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions,
- and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services.
- You are prohibited from continuously supervising the production activities of producers/sellers.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.

Document Requirements

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency
 passports or identity documents, the validity must be at least 12 months). (JPG format)
- A recent color photograph. (JPG format)
- For visa applications other than Type B1, additional documents are required, such as a supporting letter that aligns with the purpose of the visit. (PDF format)
- An outbound ticket from Indonesia. (PDF format)

Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit) (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- A recent color photograph. (JPG format)
- Boarding pass (JPG format) or Arrival Airline Tickets (PDF format)
- Return Airline Tickets (PDF format)

VOA (Visa on Arrival) holders cannot apply for a change of status to a Temporary Stay Permit (KITAS) without leaving Indonesia.
