

C12 - Pre-investment Single Entry Visa

This visa is intended for individuals who are exploring investment opportunities in Indonesia. It allows them to conduct activities such as field surveys and feasibility studies to assess the viability of starting a business in the country. The C12 visa is suitable for those who need to gather information and evaluate potential investments before making a formal commitment to establish a business in Indonesia.



Stay

Up to 180 days (extendable)

With this visa you can

- Conducting activities related to start a business, including field surveys and/or feasibility studies.
- Conducting activities related to tourism, and visiting friends or family.

You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not
 complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services, unless necessary as part of the MICE or Trade Fair in which you are participating.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.

Document Requirements for New Application

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$5,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Proof of guarantee from the guarantor (PDF format)
- Information/invitations/correspondence from government agency or private institution explaining the relationship with applicants. (PDF format)

Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency
- passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)

- Proof of guarantee from the guarantor (PDF format)
- Information/invitations/correspondence from government agency or private institution explaining the relationship with applicants. (PDF format)

Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Note:

This visa must be used within 90 days from the date of issue and allows a maximum stay of 6 months per visit. Please note that the visa validity period differs from the period of stay. Kindly check your visa for specific stay period information. A Single-Entry Visa can be converted into a KITAS without leaving Indonesia, provided that all transfer requirements are met. It can be extended. Extensions will be processed two weeks before the end of the stay period for each visit under the Single-Entry Visa.
