

C2 - Business Single Entry Visa

The C2 - Business Visa is designed for business professionals who are visiting Indonesia to attend meetings, engage in negotiations, or participate in various business activities. This visa allows individuals to conduct their professional tasks without needing a work permit, making it ideal for short-term business engagements. It is suitable for those attending conferences, establishing business contacts, or evaluating potential business opportunities within Indonesia. The C2 visa provides a legal framework for non-residents to engage in business matters without engaging in employment.



- Stay**
- Up to 60 days (can be extended twice with each extension of 60 additional days)
- With this visa you can**
- Carry out activities related to business, meetings, or purchase of goods including but not limited to checking goods at the office, factory, or production site of goods.
 - Discuss, negotiate, and/or sign business contracts.
 - Conducting activities related to tourism, and visiting friends or family.
- You must**
- Respect local customs, culture, and wisdom .
 - Comply with all visa conditions and Indonesia laws.
 - Have sufficient living expenses while in Indonesia.
- Other information**
- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
 - You are prohibited from selling goods or services
 - You are prohibited from continuously supervising the production activities of producers/sellers
 - You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia

Document Requirements for New Application

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Notification letter, assignment letter, or invitation from a government or private institution confirming that the individual is visiting Indonesia for the intended purpose. (PDF format)

Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)

Visa Validity

This visa must be used within 90 days from the date of issue, Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.
