


D2 - Multiple Entry Business Visa

D2 – Multiple Entry Tourist Visa is a visa type that allows foreign nationals to enter and exit a country multiple times within a specified period, typically for business-related purposes. Unlike a single-entry visa, which requires a new visa for each visit, the multiple-entry visa permits several visits without needing to reapply. Each stay is limited to a maximum of 60 days. The visa itself has variable validity periods, allowing you to choose for 1 year, 2 years, or 5 years. This visa is ideal for those who plan to visit the country frequently within the chosen validity period for meetings, partnerships, or business dealings.



Type of Visa D2 (1 Year)

A person who will visits Indonesia for business related purposes. You can apply for a multiple-entry visa valid for 1 year. Periods of stay for this visa will be granted for up to 60 days for each visit.

Type of Visa D2 (2 Years)

A person who will visits Indonesia for business related purposes. You can apply for a multiple-entry visa valid for 2 years. Periods of stay for this visa will be granted for up to 60 days for each visit.

Type of Visa D2 (5 Years)

A person who will visits Indonesia for business related purposes. You can apply for a multiple-entry visa valid for 5 years. Periods of stay for this visa will be granted for up to 60 days for each visit.

Stay

• Up to 60 Days per entry

With this visa you can

- Carry out activities related to business, meetings, or purchase of goods including but not limited to checking goods at the office, factory, or production site of goods.
- Discuss, negotiate, and/or sign business contracts.
- Conducting activities related to tourism and visiting friends or family.

You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services.



- · You are prohibited from continuously supervising the production activities of producers/sellers.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia

Document Requirement

- Passport valid for at least 6 (six) months (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Curriculum Vitae (CV). (PDF format)
- Proof of guarantee from the guarantor. (PDF format)
- Information, invitations, or correspondence from government agencies or private institutions that Explain the relationship with the Applicant.
 Or Statement letter from the spouse or parents explaining the family relationship with the applicant and the activities to be carried out in Indonesia, attached with a family card / similar document. (PDF format)
- Travel itinerary. (PDF format)

Document Requirement for Visa Extension Application

- e-Visa and ITK (visit stay permit) (PDF Format)
- Original Passport (physical passport)
- Proof of guarantee from the guarantor. (PDF format)
- Return Airline Tickets (PDF Format)

Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Multiple Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Note:

Stay duration is up to 60 days and can be extended twice, with each extension granting an additional 60 days. The visa must be used within 90 days from the date of issuance. It is important to note that the visa's validity period differs from the allowed period of stay, so kindly refer to your visa for specific details. A Multiple-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided all transfer requirements are met. Visa extensions should be initiated two weeks before the stay period for each visit under the Multiple-Entry Visa expires.
