

## **C11 - Exhibitor Single Entry Visa**

This visa is designed for individuals or companies participating in meetings, incentives, conventions, and exhibitions (MICE), or trade fairs in Indonesia to market their goods or services. It allows exhibitors to enter the country to showcase their products, network with potential clients, and engage in promotional activities at these events. The C11 visa facilitates business interactions and opportunities within Indonesia's vibrant trade and exhibition sectors.



### **Stay**

- Up to 60 days (can be extended twice with each extension of 60 additional days)

### **With this visa you can**

- Conducting activities related to market goods or services in MICE or Trade Fair.
- Conducting activities related to tourism, and visiting friends or family.

### **You must**

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

### **Other information**

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services, unless necessary as part of the MICE or Trade Fair in which you are participating.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.

### **Document Requirements for New Application**

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Proof of guarantee from the guarantor (PDF format)
- Invitation from government agencies or private institutions (company etc.) as the host of the MICE or Trade Fair. (PDF format)

### **Document Requirements for Visa Extension Application**

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)

- Proof of guarantee from the guarantor (PDF format)
- Invitation from government agencies or private institutions (company etc.) as the host of the MICE or Trade Fair. (PDF format)

#### Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Stay Up to 60 days (can be extended twice with each extension of 60 additional days). This visa must be used within 90 days from the date of issue. Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information. A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met. The extension will be processed two weeks before the stay period for each visit under the Single-Entry Visa expires.
