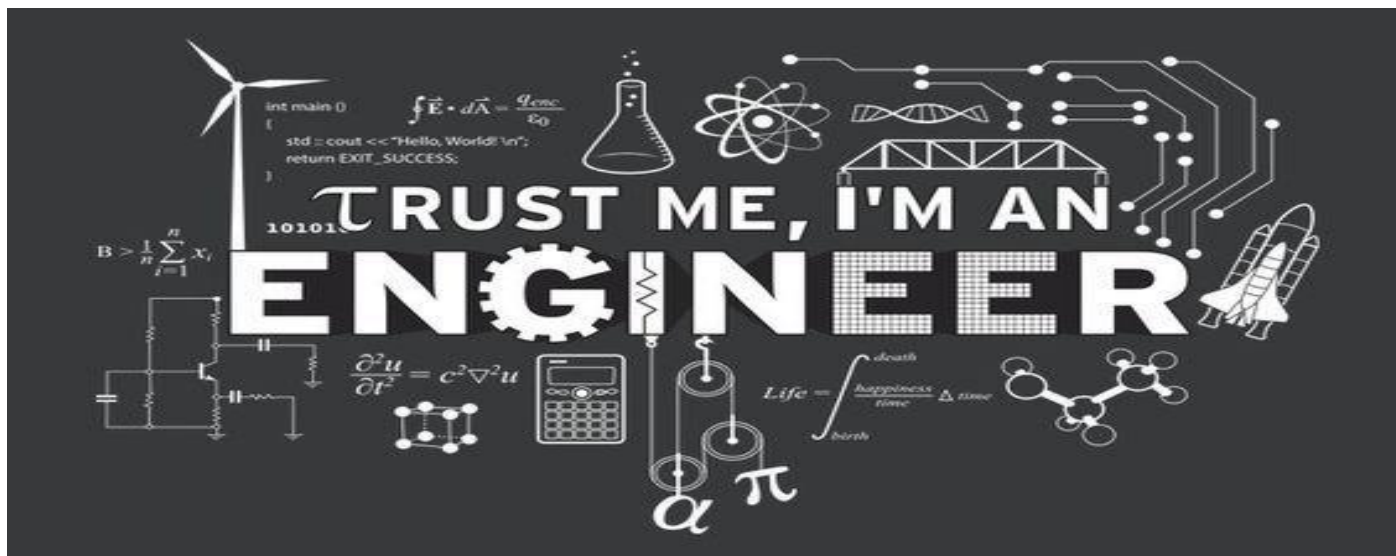


## C20 - Install and Repair Machines Single Entry Visa

This visa is intended for individuals who travel to Indonesia to provide installation and repair services for machinery purchased from abroad. It is designed for technicians and engineers who are responsible for setting up, maintaining, and repairing equipment that has been imported into Indonesia. The C20 visa facilitates the arrival of skilled professionals who ensure that machines are properly installed and functioning, supporting the operational needs of businesses and industries in Indonesia.



### Stay

Up to 60 days (can be extended twice with each extension of 60 additional days)

### With this visa you can

- Carry out activities related to machine installation and repair services in Indonesia as part of the purchase of a machine from abroad.
- Conducting activities related to tourism, and visiting friends or family.

### You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

### Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.

### Document Requirements for New Application

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Proof of guarantee from the guarantor (PDF format)
- Statement from government agency or private institution explaining that the installation and or repair of the machine must be carried out by the Foreigner concerned and cannot be represented/authorized to others. (PDF format)

### Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)
- Proof of guarantee from the guarantor (PDF format)

### Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

**Note:**  
Stay Up to 60 days (can be extended twice with each extension of 60 additional days). This visa must be used within 90 days from the date of issue, Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information. A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met. The extension will be processed two weeks before the stay period for each visit under the Single-Entry Visa expires.
