

# C21 - Attend a Judicial Process Single Entry Visa

The C21 Visa is intended for individuals who need to attend judicial processes in Indonesia, such as court hearings or legal proceedings. It is granted to those required by law or legal obligations to be present in the country for matters like court appearances or legal consultations. The visa's duration typically corresponds with the length of the legal proceedings and may be extended if necessary. Applicants must provide relevant legal documents, such as court summons, to support their application.



#### Stay

Up to 60 days (can be extended twice with each extension of 60 additional days)

### With this visa you can

- Carry out activities related to attending judicial process in Indonesia.
- Conducting activities related to tourism, and visiting friends or family.

#### You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

## Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not
  complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.

## **Document Requirements for New Application**

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency
  passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Proof of guarantee from the guarantor (PDF format)
- Information from law enforcement government agency. (PDF format)

### **Document Requirements for Visa Extension Application**

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency
  passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)
- Proof of guarantee from the guarantor (PDF format)

### Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

This visa must be used within 90 days from the date of issue, Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information. A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met. The extension will be processed two weeks before the stay period for each visit under the Single-Entry Visa expires.
