

C6 - Social Single Entry Visa

The C6 visa is intended for individuals visiting Indonesia to participate in social programs. This visa is suitable for those engaging in activities related to family visits, social gatherings, or religious events. It is also applicable for individuals involved in social outreach programs, community services, or other non-commercial activities aimed at benefiting society. The C6 visa facilitates the entry of those who wish to contribute to or be part of social initiatives within the country.



Stay

- Up to 60 days (can be extended twice with each extension of 60 additional days)

With this visa you can

- Conducting activities related to social program in Indonesia.
- Conducting activities related to tourism, and visiting friends or family.

You must

- Respect local customs, culture, and wisdom .
- Comply with all visa conditions and Indonesia laws.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from selling goods or services.
- You are prohibited from receiving rewards, wages, or any similar from individuals or corporations in Indonesia.

Document Requirements for New Application

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Notification letter, assignment letter, or invitation from a government or private institution confirming that the individual is visiting Indonesia for the intended purpose. (PDF format)

Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)

Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Note: This visa is intended for foreign nationals who wish to visit Indonesia for non-tourism purposes for a maximum of 6 months without plans to leave Indonesia. The extension will be processed one week before the stay period for each visit under the Single-Entry Visa expires.
