

# C7A - Music Performer Single Entry Visa

This visa is designated for individuals who are coming to Indonesia specifically to perform music. It is intended for musicians, bands, or solo artists participating in concerts, music festivals, or other musical events. The C7A visa allows these performers to enter Indonesia for the duration of their music engagements, providing them with the necessary legal status to carry out their performances and contribute to the vibrant music scene in the country.



## Stay

Up to 30 days (cannot be extended)

### With this visa you can

- Performing music performances.
- Receiving rewards or facilities for activities carried out.
- Conducting activities related to tourism and visiting friends or family.

## You must

- Respect local customs, culture, and wisdom.
- Comply with all visa conditions and Indonesia laws.
- Have sufficient living expenses while in Indonesia.

### Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not
  complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from staying in Indonesia over the period of your residence permit.
- You are prohibited from selling goods or services.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.
- You are prohibited from Performing art, culture, or behavior that is not in accordance with applicable regulations or norms.

## **Document Requirements for New Application**

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Notification letter, assignment letter, or invitation from a government or private institution confirming that the individual is visiting Indonesia for the intended purpose. (PDF format)

**Additional Document Requirements for New Application** 



- Guarantee letter from the event organizer (PDF format)
- · Visa application from the impressariat and the performer's cooperation contract with the event organizer. (PDF format)

### **Visa Validity**

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.
