

C8B - Sport Single Entry Visa for crew and official

This visa is intended for sports officials, coaches, or other support staff who are invited by the Indonesian government, international sports championships, or international sports organizations to assist in sports activities in Indonesia. It allows these individuals to enter and stay in the country to fulfill their roles during sports events or tournaments. The C8B visa is specifically designed for those who support or manage the sports activities but are not participating as athletes.



Stay

- Up to 60 days (can be extended twice with each extension of 60 additional days)

With this visa you can

- Engaging in sports-related activities.
- Conducting activities related to tourism, and visiting friends or family.

You must

- Respect local customs, culture, and wisdom .
- Comply with all visa conditions and Indonesia laws.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from staying in Indonesia over the period of your residence permit.
- You are prohibited from selling goods or services.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.

Document Requirements for New Application

- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Visa application letter. (PDF format)
- Travel itinerary / airline tickets. (PDF format)
- Notification letter, assignment letter, or invitation from a government or private institution confirming that the individual is visiting Indonesia for the intended purpose. (PDF format)

Additional Document Requirements for New Application

- Guarantee letter from the event organizer (PDF format)
- Invitation from event organizer. (PDF format)

Document Requirements for Visa Extension Application

- e-Visa and ITK (Visit Stay Permit). (PDF format)
- A valid passport with at least 6 (six) months of validity remaining (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format) or Original Passport (physical passport)
- Return Airline Tickets (PDF format)
- Guarantee letter from the event organizer (PDF format)
- Invitation from event organizer. (PDF format)

Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Stay Up to 60 days (can be extended twice with each extension of 60 additional days). This visa must be used within 90 days from the date of issue, Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information. A Single-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met. The extension will be processed two weeks before the stay period for each visit under the Single-Entry Visa expires.
