

## E30 – Student Visa

Indonesia offers study visas designed for international students, allowing them to pursue academic programs with stay durations of 1 or 2 years, depending on the length of their studies. These visas cater to students enrolled in various educational institutions, including high schools, universities, and language programs. The initial visa duration can be extended, providing flexibility for students who wish to continue their education beyond the original period. To obtain a study visa, applicants must secure admission to a recognized educational institution in Indonesia and demonstrate sufficient financial resources to cover tuition fees and living expenses. This visa not only facilitates academic growth but also encourages cultural exchange, allowing students to immerse themselves in Indonesia's rich cultural heritage while gaining valuable educational experiences.



### E30A – Student Visa

This visa is intended for international students who plan to study in academic institutions equivalent to primary to high school. This visa allows students to follow educational programmes designed for younger students, such as primary to higher secondary education or vocational training. The duration of the Student Visa can be for 1 or 2 years, with the possibility of extension for an additional 1 or 2 years, depending on the study programme. This visa allows students to immerse themselves in the Indonesian education system while experiencing Indonesian culture and lifestyle.

### E30B - Undergraduate, postgraduate, dan doctoral

This visa is tailored for students pursuing higher education degrees at colleges or universities, including undergraduate, postgraduate, and doctoral programs. Students can apply for an initial stay of 1 or 2 years based on their program's duration, with the option to extend the visa for further study. This type of visa facilitates academic growth and research opportunities while allowing students to participate in Indonesia's vibrant academic community and cultural landscape.

#### Stay

- Up to 1 Year (Extendable)
- Up to 2 Years (Extendable)

#### With this visa you can

- Carry out activities related to education in Indonesia.
- Bring eligible members of your family.
- Enter and leave the territory of Indonesia as long as the re-entry permit is still valid.
- Conduct activities related to tourism and visiting friends or family.

#### You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

#### Other information

- If you meet the conditions, you will automatically obtain the Electronic Limited Stay Permit (e-ITAS) and the Re-Entry Permit upon arrival at the Immigration Checkpoint (you do not need to go to the immigration office to obtain a Limited Stay Permit and Re-Entry Permit).
- Staying in Indonesia beyond the period of your residence permit, engaging in prohibited activities, not complying with visa requirements, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- In addition to the electronic limited stay permit, the limited stay permit also has a physical card available at the immigration office.
- You are prohibited from doing work or employment.
- You are prohibited from selling goods or services.

- You are prohibited from receiving rewards or wages from individuals or companies in Indonesia.

#### Document Requirement

- Passport: Must be valid for at least 6 months. For holders of other travel documents (e.g., emergency passports, identity documents), validity must be at least 12 months. (JPG Format)
- Proof of Living Expenses or Personal Bank Statement: Minimum balance of USD \$2000 or equivalent for the past 3 months, including name, statement period, and account balance. (PDF Format)
- Latest Color Photograph: Recent passport-sized photo. (JPG Format)
- Curriculum Vitae (CV) (PDF Format)
- Travel Itinerary: Confirmed travel details. (PDF Format)
- Guarantee letter from a guarantor, which is an Indonesian citizen or the educational institution where foreigners carry out education. (PDF format)
- Letter of acceptance from the educational institution in Indonesia that explains the length of time the foreigner will be enrolled in the educational institution. (PDF Format)

#### Renewal Document Requirement:

- Passport: Must be valid for at least 18 months. For holders of other travel documents (e.g., emergency passports, identity documents), validity must be at least 12 months. (JPG Format)
- Proof of Living Expenses or Personal Bank Statement: Minimum balance of USD \$2000 or equivalent for the past 3 months, including name, statement period, and account balance. (PDF Format)
- E-Visa & ITAS: Current visa and temporary stay permit. (PDF Format)
- Curriculum Vitae (CV) (PDF Format)
- Guarantee letter from the guarantor. (PDF format)
- Guarantee letter from a guarantor, which is an Indonesian citizen or the educational institution where foreigners carry out education. (PDF format)
- Letter of acceptance from the educational institution in Indonesia that explains the length of time the foreigner will be enrolled in the educational institution. (PDF Format)
- Domicile Letter: Proof of residence in Indonesia. (PDF Format)
- SKTT (Temporary Residential Registration): Proof of temporary residency. (PDF Format)

#### Visa Validity

This visa must be used within 90 days from the date of issue.

Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

**The cancellation of KITAS or not extending KITAS can be done in the following ways:**

1. Submit an EPO (Exit Permit Only) to the nearest Immigration Office, two weeks before leaving Indonesia. After receiving the EPO stamp, you must exit Indonesia within a maximum of 7 days from the approval of the EPO.
2. Submit an ERP (Exit Re-entry Permit) when you are not in Indonesia and have decided to cancel or not extend your KITAS. This can be done by contacting the nearest Indonesian Embassy.
3. You cannot apply for another type of visa while you have not completed the EPO/ERP process, which may result in a fine.
