

# D7 – General Art performer & Crew Multiple Entry Visa (30 Days)

The D7 Visa is a type of multiple-entry visa that allows individuals to display or perform works of art and culture, such as dance, theater, and other artistic expressions, with a stay of up to 30 days. However, it is important to note that this visa cannot be extended. This means that while holders can enter and exit Indonesia multiple times during its validity, they must ensure that their activities are completed within the designated time frame. For those in the music field, a separate visa is required to accommodate specific performance regulations.

For those wishing to stay longer than 30 days while having the flexibility to enter and exit Indonesia, it is recommended to opt for a KITAS (Limited Stay Visa) for impresario. This type of visa provides a longer duration of stay and allows for multiple entries, making it ideal for individuals involved in cultural or artistic activities who require more time to carry out their work and commitments in Indonesia.

# With this visa you can

- Engaging in arts and culture-related activities, including but not limited to theatre, dance, and circus performances.
- Receiving rewards or facilities for activities carried out.
- Conducting activities related to tourism and visiting friends or family.

### You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

### Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not
  complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from staying in Indonesia over the period of your residence permit.
- You are prohibited from selling goods or services.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.
- You are prohibited from performing art, culture, or behavior that is not in accordance with applicable regulations or norms.

- Passport valid for at least 6 (six) months (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Curriculum Vitae (CV). (PDF format)
- Guarantee letter from the event organizer or impresario. (PDF format)
- Visa application from the impresario and the performer's cooperation contract with the event organizer. (PDF format)
- Travel itinerary. (PDF format)

## Visa Validity

This visa must be used within 90 days from the date of issue. Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Multiple Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

### Note:

Stay duration is up to 30 days. The visa must be used within 90 days from the date of issuance. It is important to note that the visa's validity period differs from the allowed period of stay, so kindly refer to your visa for specific details. A Multiple-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided all transfer requirements are met.
