

D8A – Sport Multiple Entry Visa (60 Days)

The D8A Visa is designed for individuals who will participate in sports activities in Indonesia, specifically those invited by the Indonesian government or involved in international sports championships. This visa is also applicable to athletes participating in events organized by international sports organizations. It allows for a stay of up to 60 days and cannot be extended, providing an adequate timeframe for athletes to engage in competitions, training, or other sports-related activities. The D8A Visa facilitates the entry of athletes into Indonesia, supporting their participation in significant sporting events while ensuring compliance with the country's visa regulations.



Stay

• Up to 60 Days

With this visa you can

- Engaging in sports-related activities.
- Receiving rewards or facilities for activities carried out.
- Conducting activities related to tourism, and visiting friends or family.

You must

- Comply with laws and regulations.
- Respect local customs, culture, and wisdom.
- Have sufficient living expenses while in Indonesia.

Other information

- Staying in Indonesia over the period of your stay permit, engaging in prohibited activities, not complying with visa conditions, and/or not complying with Indonesian laws may result in you paying fines, being deported, and/or other legal charges.
- You are prohibited from staying in Indonesia over the period of your residence permit.
- You are prohibited from selling goods or services.
- You are prohibited from working in an employment relationship with an individual or corporation in Indonesia.

Document Requirement

- Passport valid for at least 6 (six) months (for holders of travel documents other than passports, such as emergency passports or identity documents, the validity must be at least 12 months). (JPG format)
- Personal bank statement showing a minimum balance of USD \$2,000 or equivalent for the last 3 months (including the account holder's name, statement period, and account balance). (PDF format)
- A recent color photograph. (JPG format)
- Curriculum Vitae (CV). (PDF format)
- Guarantee letter from the event organizer. (PDF format)
- Invitation from event organizer. (PDF format)
- Travel itinerary. (PDF format)

This visa must be used within 90 days from the date of issue. Please note that the visa validity period is different from the period of stay, kindly check your visa for the period of stay Information.

A Multiple Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided that all transfer requirements are met.

Stay duration is up to 60 days. The visa must be used within 90 days from the date of issuance. It is important to note that the visa's validity period differs from the allowed period of stay, so kindly refer to your visa for specific details. A Multiple-Entry Visa can be converted into a KITAS without the need to leave Indonesia, provided all transfer requirements are met.
